Re: Food Distribution Program on Indian Reservations (FDPIR)

To whom it concerns:

The Food Distribution Program (FDPIR) is a Federally Funded Program and all or most of the funding is provided by the United States Department of Agriculture (USDA), Food & Nutrition Service (FNS). Similar to Supplemental Nutrition Assistance Program (SNAP) we serve participants that meet financial eligibility guidelines outlined in the FDPIR Handbook FNS-501.

Within the FNS-501 Handbook each individual tribal FDPIR has to submit a State Plan of Operation. The State Plan of Operation, includes the outline our service area, which is currently the 14 counties of West Central Wisconsin. This State Plan of Operation is an agreed upon criteria between our Tribal President and the authorization of USDA-FNS headquarters Midwest Regional Office-Chicago.

## **FOOD DISTRIBUTION PROGRAM ON INDIAN RESERVATIONS (FDPIR) FY 2020 NET MONTHLY INCOME STANDARDS** (Effective October 1, 2019 to September 30, 2020)

The net monthly income standard for each household size is the sum of the applicable Supplemental Nutrition Assistance Program (SNAP) net monthly income standard and the applicable SNAP standard deduction.
