### **Water System Information:**

#### Water Source:

The water that supplies the Indian Heights Community is groundwater pumped from two wells located in the Community. The water is then disinfected, treated for corrosion, and fluoride is added.

# **Information on Types of Testing Conducted:**

The testing requirements for your system are based on the types of contaminants that may be present in raw water. These include microbial contaminants, inorganic contaminants, pesticides and herbicides, radioactive contaminants, and organic chemical contaminants.

- ♦ <u>Microbial Contaminants</u>; such as viruses and bacteria, may come from septic systems, agricultural and livestock operations, and wildlife.
- <u>Inorganic Contaminants</u>; such as salts and metals can be naturally occurring or result from storm water runoff, industrial or domestic wastewater discharges, mining or farming.
- Pesticides and Herbicides; may come from a variety of agricultural and residential uses.
- ♦ Radioactive Contaminants; are naturally occurring.
- Organic Chemical Contaminants; including synthetic and volatile organic chemicals are by-products of industrial processes and petroleum production. The main sources that we are concerned about are gas stations, garbage dumps, illegal dumping, storm water runoff and septic systems.

# **Educational Information:**

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. #### **ADDITIONAL HEALTH STATEMENT:**

Lead: Lead in drinking water is rarely the sole cause of lead poisoning, but it can add to a person's total lead exposure. All potential sources of lead in the household should be identified and removed, replaced or reduced. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
